PURPOSE OF THE POSITION

Child Protection Officer will support the provision of quality services for the UASC-24/7 component in TRC Ušivak providing services to beneficiaries (unaccompanied and separated migrant children, minors) and World Vision staff

MAIN RESPONSIBILITIES:

Provide support to Child protection activities within the UASC-24/7 unit in order to support WVBiH migrant response activities:

- Providing support to UASC-24/7 Staff in process of registering children/minors
- Conduct vulnerability assessments of separated and unaccompanied migrant children (UASCs) to help identify the urgent needs and possible solutions for children;
- Exchanging with other UASC-24/7 Staff in order to approach each beneficiary in the most appropriate way;
- Facilitate group and individual activities within UASC protection services;
- Assist in guiding interviews with beneficiaries to gather resources that are child-focused, respectful and demonstrative of the realities and challenges that the refugees face.
- Creating a trustful relationship with beneficiaries;
- Guaranteeing the confidentiality, impartiality and neutrality;

- Taking an active part in all necessary collateral activities linked to the beneficiaries' health and social assistance, including information and advocacy.
- Perform other duties as may be assigned.

REQUIREMENTS OF THE POSITION:

- University Degree in relevant field or equivalent minimum 3 years working with children
- Professional experience in the field of social services or in organisations which deal with immigrants or poverty alleviation is an asset;
- Attuned to Child Protection issues especially in emergencies preferred
- Willingness to work in difficult environment
- Willingness to work as part of a multidisciplinary team;
- · Ability to work and problem-solve in high-stress situations;
- Openness to others
- Demonstrates ability to work collaboratelly with colleagues and partners
- Shows genuine care and empathy for others, expressed in appropriate ways for the context
- Take the initiative to quickly respond to critical situations or opportunities
- Computer literacy (office package)
- Fluent English written and spoken preferred
- Maintains high ethical standards and acts in a manner consistent with organizational principles/rules, code of conduct and WVI core values https://www.wvi.org/our-core-values
